A motion by Bills was made to start work on fixing the tile under Ash Street and was seconded by Leider. All Ayes.

Council woman Riggert made a motion to approve both building permits and seconded by Neuroth. All Ayes.

Councilman Neuroth made a motion to receive two bids for a new air conditioner for the library and approve the lowest bid of the two seconded by Bills. All ayes.

A motion by Riggert was made to increase City Hall employees wage \$0.50 across the board, seconded by Neuroth. All Ayes.

Bills made a motion to approve the move of Community Corp liquor license to South Park for July 4th seconded by Leider. All ayes.

A motion was made by Bills and seconded by Youngwirth to adjourn meeting. All ayes.
